
## NOTICE OF ANNUAL GENERAL MEETING

- 5. To transact any other business with the permission of the Chair.

- 1. The Members' Register will remain closed from 22-10-2014 to 28-10-2014 (both days inclusive). Transfers received at Hamced Majeed
- Associate (Pvt) Limited, II.M. House, 7-Bank Square, Lahore, the Registrar and share transfer office of the Company by the close of business on 21-10-2014 will be considered in time for attending the AGM and for above entitlement.
- 2. A member eligible to attend and vote at this meeting may appoint another member as proxy to attend and vote in the meeting. Proxies in order to be effective must be received by the company at the Registered Office not later than 48 hours before the time for holding the meeting.
- 3. Shareholders are informed that Income Tax Ordinance, as amended by Finance Act., 2014 has prescribed 15% withholding tax on dividend payment to non-filers while filers of income tax returns will be liable to withholding tax @10%. Shareholders are advised to provide their NTN to Share Registrar's of the Company for availing the benefit of withholding tax rate applicable to filers.
- 4.SECP through its Notification SRO 787/(i)/2014 dated September 8, 2014, has allowed the circulation of Audited Financial Statements along with the Notice of Annual General meeting to the members of the Company through email. Therefore all members who want to receive the soft copy of Annual Report are requested to send their email addresses. - 5. Shareholders are requested to immediately notify the change in address, if any.
- 6. CDC account holders will further have to follow the following guidelines as laid down by the Sceurities and Exchange Commission of Pakistan:
- a. For attending the meeting
- i) In case of individuals, the account holder or sub-account holder and/or the person whose securities are in group account and their registration details are uploaded as per the Regulations, shall authenticate his/her identity by showing his original Computerized National Identity Card (CNIC) or original passport at the time of attending the meeting.
- ii) In case of corporate entity, the Board of Directors' resolution/power of attorney with specimen signatures of the nominee shall be produced (unless it has been provided earlier) at the time of the Meeting

- b. For Appointing Proxies
- i) In case of individuals, the account holder or sub-account holder and/or the person whose securities are in group account and their registration details are uploaded as per the Regulations, shall submit the proxy form as per the above requirement.
- ii) The proxy form shall be witnessed by two persons whose names, addresses and CNIC numbers shall be mentioned on the form.
- iii) Attested copies of CNIC or the passport of the beneficial owners and the proxy shall be furnished with the proxy form.
- iv) The proxy shall produce his original CNIC or original passport at the time of the Meeting.
- v) In case of corporate entity, the Board of Directors' resolution/power of attorney with specimen signatures shall be submitted (unless it has been provided earlier) along with proxy form to the company.
